She asked the Board members if they had any comments or corrections. The Board members stated that they did not have any comments or corrections. Ms. Johnson finished by stating that Arapahoe County and Pueblo County had signed off on the comment letter.

# **Board of County Commissioners (BoCC) Continued Follow-up Discussion March 15, 2016 – Study Session**

Ms. Mathisen stated that Mr. Pacyga wanted this agenda item back on for discussion since Mr. Dahlman was not present at the Special Board meeting on March 15, 2016. After discussion the Board asked Ms. Mathisen to prepare an expense comparison between the Adams County Retirement Plan and similar size pension plans.

#### **STANDING REPORTS**

Watershed Investment Consultants, Inc. Investment Updates – Performance Update

Mr. Connors stated that the performance for the month of February 2016 was not good. However, for the month of March 2016 the S&P was up 6.8%. Mr. Connors stated that the market is extremely volatile and not trading on fundamentals.

Mr. Connors informed the Board that the funds from GAM were not invested into Visium Asset Management but had been placed in the Operating account. He stated that there has been an inquiry from the SEC regarding possible fraudulent active involving insider trading through the Visium network of consultants in the healthcare field. Mr. Connors indicated that Watershed Investment Consultants will not invest the funds into Visium until a decision has been made by the SEC.

#### **Gabriel Roeder Smith & Company**

Ms. Thompson stated that Gabriel Roeder Smith is on track to present the valuation at the June 2016 Board meeting.

Retirement Staff – Administrative Business Administrative Updates 2015/2016 Income/Expenditure Report

Ms. Haines indicated that included in the Board packet were two Income/Expenditure Reports one for 2015 and the other through March 2016. She stated that these reports show the contributions coming into the Plan as well as refund payments, retiree payments and expenditures going out of the Plan.

#### **US Bank**

Ms. Mathisen thanked Ms. Seberg for attending the Board meeting. Ms. Seberg informed the Board that on all of the Adams County Retirement Plans accounts there is what is called a sweep vehicle. She stated that this is an interest bearing money market deposit account. Ms. Seberg informed the Board that the rate of return was increased from 5 basis points to 20 basis points.
