Adams County Board of Retirement Reorganization

Mr. Morgen moved to leave the current slate of officers as is Marc Osborne, Chairman, Ben Dahlman, Vice-Chairman, Brigitte Grimm, Treasurer, Jim Morgen, Secretary and Brent Voge, Member at Large. Mr. Dahlman seconded and it was unanimously carried.

STANDING REPORTS

Ellwood – Dale Connors Investment Update 2017 Year End Performance Evaluation

Mr. Connors started by commenting on the downturn in the market in February 2018. He told the Board that they should not panic, it was probably overdue. However, it did wipeout all the gains for 2018.

Mr. Fiegel continued with the presentation of the 2017 Year End Performance Evaluation to the Board of Retirement. He stated that 2017 produced positive results in the equity markets. Mr. Fiegel stated that both in the developed and emerging markets the technology sector was the largest contributor to the equity market.

Mr. Connors finished by handing out a 2018 Investment Outlook by Ellwood's Capital Markets Committee. He stated that Ellwood expects the economic conditions will be supportive of equities with valuations leading them to favor international developed and emerging markets relative to a more neutral view on US markets. Mr. Connors stated that there will be a potential for inflation to trend higher in 2018, Ellwood sees an opportunity for real assets to contribute to portfolio returns. Mr. Connors continued with the performance on the Adams County Retirement Plan for 2017. He indicated that overall the Adams County Retirement Plan had a great year up 12.73% net of fees for 2017. He stated the Plan finished 2017 at \$262,329,975.

Davis Graham & Stubbs Legal Information Updates

Ms. Birley indicated that Davis Graham & Stubbs has been updating some of the Administrative forms for the Adams County Retirement Plan. She stated that several years ago the Plan had adopted the IRS guidelines on "True Separation". Ms. Birley stated that since the IRS is cracking down on this guideline Davis Graham & Stubbs is updating some of the forms with more robust language regarding separation.

Gabriel Roeder Smith & Company Update

Mr. Woods thanked Ms. Haines for getting all the actuarial data to GRS. They are now working on the Actuarial Valuation for the Adams County Retirement Plan.

Retirement Staff – Administrative Business

Ms. Haines indicated that included in the Board packet was the year-end Income/Expenditure Statement. She stated that this report shows the contributions coming into the Plan as well as refund payments, retiree payments and expenditures going out of the Plan.

Ms. Mathisen thanked the Board personally for the flowers she received while she was out of the office. She also wanted to thank Ms. Haines for the job well done while she was out of the office. Ms. Mathisen stated that she was out the worst possible time and Ms. Haines did an amazing job.
